You agree to credit photographer as copyright owner in conjunction with any reproduction so granted. **Images are not for sale or license to third parties.**

In a photo session after shooting is finished I will prepare for you a photo gallery of unretouched proofs of all shots saved. The photos will have a *proof* and a *Copyright* stamp on the face of the images. You agree that these are for your use only to assist you in choosing images you would like me to consider for retouching. Proofs are not for distribution (to friends, grandma, MySpace, etc...) and are not to be published in any way including posting on a Web site or otherwise made available to appear on any person's Web browser. Copyright notices are not to be removed from photos


